Definitions and key terms

To help explain things as clearly as possible in this Return & Refund Policy, every time any of these terms are referenced, are strictly defined as:

- **Company:** when this policy mentions “Company,” “we,” “us,” or “our,” it refers to ME Solutions, that is responsible for your information under this Return & Refund Policy.
- **Customer:** refers to the company, organization or person that signs up to use the ME Solutions Service to manage the relationships with your consumers or service users.
- **Device:** any internet connected device such as a phone, tablet, computer or any other device that can be used to visit ME Solutions and use the services.
- **Service:** refers to the service provided by ME Solutions as described in the relative terms (if available) and on this platform.

Return & Refund Policy

If you would like to return a product, the only way would be if you follow the next guidelines:

- The package needs to come back with the original receipt of the purchase.
- The product has to be in the same packaging we sent it.

Refunds

Sadly, there are times when we may not have the product(s) that you choose in stock, or may face some issues with our inventory and quality check. In such cases, we may have to cancel your order. You will be intimated about it in advance so that you don't have to worry unnecessarily about your order. If you have purchased via Online payment (not Cash on Delivery), then you will be refunded once our team confirms your request.

We carry out thorough quality check before processing the ordered item. We take utmost care while packing the product. At the same time we ensure that the packing is good such that the items won't get damaged during transit. Please note that ME Solutions is not liable for damages that are caused to the items during transit or transportation.

We will revise your returned product as soon as we receive it and if it follows the guidelines addressed above, we will proceed to issue a refund of your purchase. Your refund may take a couple of days to process but you will be notified when you receive your money.

Shipping

ME Solutions is not responsible for return shipping costs. Every shipping has to be paid by the customer, even if the item had free shipping, the customer has to pay for the shipping in return.
